



2021 CVC OF ATLANTA MEMBER PARTNER APPLICATION
DEADLINE FOR APPLICATION: November 30, 2020 (5 p.m.)

Thank you for your interest in the Corporate Volunteer Council of Atlanta (CVC). The CVC is a nonprofit organization that supports its members in their strategic commitment to corporate employee volunteerism and civic engagement.

Nonprofit organizations are eligible to apply for Member Partner status with the CVC every two years. The role of Member Partners is to offer a nonprofit perspective on workforce volunteerism, including volunteerism trends and access to corporate volunteer opportunities. The CVC limits the number of Member Partners for each 2-year term to a maximum of 15 organizations. The CVC reserves the option to encourage diversity of size and geographical balance within the Atlanta region in considering Member Partner selection. The CVC may also accept fewer than 15 organizations as Member Partners in any period.

Organizations that have served as Member Partners in the past are welcome to apply again for a new 2-year term. The CVC may or may not grant consecutive, 2-year terms to Member Partners.

Applicant organizations must provide the requested information and responses to the questions below in a Word document not to exceed three pages. Organizations selected as Member Partners will be assessed a nonprofit dues rate of \$150 annually during their term. Applications will be reviewed by the CVC's Membership and Governance Committees and approved by the CVC board of directors. All decisions of the board are final.

Include the following information:

1. Organization name and mission
2. Key contact – name, title, email, phone number
3. Total number of volunteers participating in your organization's activities during your most recent fiscal year (please indicate starting date of fiscal year)
4. Total number of volunteer hours contributed on behalf of your organization during your most recent fiscal year
5. Number and description of corporate volunteer opportunities offered by your organization during most recent fiscal year

Please answer the following questions:

1. How do volunteers support your organization's mission and programs?
2. Have you worked with or do you work with any current CVC of Atlanta members (CVC members listed at www.cvcofatlanta.org/members)?
3. Has your organization served as a CVC of Atlanta Member Partner in the past? If so, how did your organization participate?
4. Why are you interested in becoming a Member Partner of the CVC of Atlanta?
5. Please provide how you can offer CVC of Atlanta members opportunities in the following areas:
 - a. Group volunteer opportunities (include size limitations/minimums)
 - b. Skill-based volunteer opportunities
 - c. Unique volunteer opportunities
 - d. Professional expertise in volunteer management
6. Please describe the diversity of your organization including staff, board of directors and population served. Does your organization actively work to attract and retain diverse volunteers? Please explain.
7. Member Partners bring an important perspective to CVC of Atlanta and may be invited to speak at a program. What expertise might your organization provide to corporate members of CVC of Atlanta?
